FINANCIAL REVIEW AND BUDGET ADJUSTMENT REQUEST

Ms. Leslie Lujan presented the most current Financial review and Budget Adjustment Request (BAR). Ms. Lujan stated ACE Leadership High School is in the process of being audited as per the Stated guidelines. This is why the July 2019 report analysis shows an unavailable under the Fund balance. As the audit ends those numbers will be confirmed and entered.

Ms. Lujan provided an explanation of BAR 001-749-1819-0001-IB, noting this was the result of an award letter stating a 3-year school improvement grant. The first supplement of the award is a planning component, which is reflected in the proposed BAR. Mrs. Tori Stephens-Shauger, Executive Director/Principal provided her monthly Director's report. An overview was presented on potential partnerships with University of New Mexico (UNM) College of Education professors relating to developing school leaders. Mrs. Stephens-Shauger has been invited to speak to a group of charter school authorizers at the Nation Charter School Authorizers conference in October. PED grants have been received by ACE Leadership High School to work on increasing attendance. Another grant has been received to work on literacy, specifically centering on ACE's bilingual seal options. There will be two Board orientation opportunities, Thursday, August 23, 2018 and Tuesday, August 28, 2018, if any members would like to attend please contact Mrs. Stephens-Shauger. There will be some funding changes occurring for students due to a recent court ruling called Martinez vs. Yazzie.

Mrs. Stephens-Shauger presented upcoming data that will be reviewed through the year and the information the Governing Board will see in the upcoming months. It was a notable mention in 2017 PARCC participation of 2017 there were 40 participants in Math and 51 in ELA versus 2018 with Math at 74 and ELA 100.

Lastly, Mrs. Stephens-Shauger presented the 2018 report card. It was an F final grade. Mrs. Stephens-Shauger presented data of increased scores and items that still need improvement.

Chair Hatchell stated that the Board training debrief will be addressed in an upcoming meeting.

Ms. Leslie Lujan presented the most current Financial review and Budget Adjustment Request (BAR). Ms. Lujan stated ACE Leadership High School is in the process of being audited as per the Stated guidelines. The auditors are still reviewing information and have been working on a fixed asset review of the past six years.

Ms. Lujan provided an explanation of BAR 001-749-1819-0003-IB, noting this was to pay the lease Ms. Juvera made the motion to approved the BAR and Chairman Hatchell seconded the motion; it was unanimously approved. It was moved:

A brief discussion ensued on financing the building. At this time the ACE Foundation is working with an institution to revise the amortization schedule. The Foundation is working on the aspects to have the situation taken care of.

DISCUSSION ITEMS

Mrs. Tori Stephens-Shauger, Executive Director/Principal provided her monthly Director's report. There are approximately 250 students enrolled on the 40th day report. This is 100 students short from the previous year. The hope is to have 365 students for the 80/120 average. Some of the reasons for the drop in enrollment numbers are due to transportation problems and families moving. Mrs. Stephens-Shauger provided an overview of placement data from the 2018 class. ACE had a total of 56 graduates of our 2018 school year, 28% of the 46 surveyed from the class of 2018 are working in ACE industries. A discussion ensued as to what companies those individuals are working for Mrs. Stephens-Shauger stated she would get that list of companies.

The staff complaint resolution policy was introduced. After a brief discussion it was decided the policy needs to be crafted as to help the adults and students of the school . Ms. Lewis will continue to work on a draft for discussion at the November meeting.

Mrs. Ronda Gilliland-Lopez presented a draft of the bylaws. It appeared a set of bylaws away from the charter application had not been completed. After a brief discussion it was decided Mrs. Abby Lewis will review and provide input.

Mr. Everette Hill, of Social Innovation Strategies Group, LLC was introduced to the group. Mr. Hill stated now is the time to create a framework for the school, we have a new year, new authorizer, new leadership teams, and new board plan. Mr. Hill reviewed the schools ideas for trust and relationship growth. How to build the trust with the current relationship. It was noted the relationship between the General Council and the Executive Director needs to grow by looking forward and stop looking back. Mr. Hill provided some techniques to work for a better relationship between the Governing Council and the school.

Mrs. Stephens-Shauger stated on the 40th day report there were 249 students. ACE will see an increase in enrollment in January. The goal for the 80/120 day average is 385.

Mrs. Stephens-Shauger reviewed the authorizer annual site visit. It appeared to be a positive visit, there are some policies the new authorizer would like to have in the educational plan, governance frameworks and communication in the financial framework.

As a final note on the executive director's report Mrs. Stephens-Shauger provided an update on the charter school design team. Mrs. Stephens-Shauger reminded the Board it's time to prepare for her mid year evaluation and would like to know what is needed in order to begin the process.

FINANCIAL REVIEW

Ms. Leslie Lujan reviewed the November 2018 report analysis. Ms. Lujan explained there has been a software conversion causing some glitches that are being worked out. Ms. Lujan mentioned the IRS is auditing Yearout Mechanical concerning work that was completed on the building 7 years ago. Ms. Lujan will keep the Governing Council informed if there are any actions needed.

Ms. Lujan noted the projections for students and funding for the school year 2019/2020 appears to be on task.

The Governing Council thanked Ms. Lujan.

DISCUSSION ITEMS

Mr. Sean Calvert, Chairman of the ACE Foundation, was introduced to the Governing Council. Mr. Calvert stated over the years the Foundation would have projects to work on in conjunction to the school, the driving focus has been the building and the loans on the building. At this time the smaller balloon payment has been planned and budgeted for payment. The larger payment is being worked on for a refinance and appears that there will be no financial consequences to ACE due to the impeccable payment schedule and deadlines that have been met by the school. In the last several months Mr. Calvert, Ms. Lujan and Mrs. Stephens-Shauger have been working to clarify who signed the original loans. The Foundation would be working on the next focus and would like to know what the general council would like the focus to be. The current ACE Foundation Board is: Mr. Calvert, Mrs. Melissa Gomez from JB Henderson, Ms. Becky Auge from Yearout Mechanical, Mr. Michael Vigil from MV Industries, and Felicia [REDACTED] from Sandia National Labs. Mr. Calvert stated the Foundation Board would like input and direction from the Governing Council. Ms. Crystal Medrano clarified the fundraising would not be geared to pay off the loans and it was confirmed. After a brief discussion it was decided the new focus should be to help raise funds for paid internships. This would ultimately assist ACE Foundation in marketing our students' strong points while providing incentive to the students to work hard in their field of study. Creating scholarships to assist employers, funding to assist with the Capstone process and supporting and creating mentorships in exhibitions. Mr. Calvert was thanked for attending the meeting.

Mrs. Tori Stephens-Shauger, Executive Director/Principal provided her monthly Director's report:

Mrs. Stephens-Shauger reviewed a recent visit with Mr. Jerry Arms of Sheet Metal Workers/SMART Local 49, Mr. Kocurek as well as ACE staff to discuss the metal fabrication lab. ACE is working on the capital outlay building. This will allow students the opportunity to really learn the mechanical field.

Mrs. Stephens-Shauger stated on the 80th day report there were 282 students, 33 student increase over the 40th day. Mr. Mike Puelle asked what is the school's cap for students and was informed the charter states 435 students.

Mrs. Stephens-Shauger reviewed the outline of discussion of categories and indicators for APS Charter academic framework. This has been an excellent exercise because APS is working on understanding and creating measurements for nontraditional means of learning and measuring the success. The indicators are still in the discussion and draft phases, however there will be a weight and balance calculation placed to these items. These will be the APS performance measurements for charter school. The PARCC will still be a measurement but will not hold the same weight as it has with the Public of Education Department (PED). PED will still have their report card, however, with the new Governor taking office and changing leadership roles there may be changes in the current forms of measurements. Ms. Abbey Lewis took a moment to compliment Mrs. Stephens-Shauger as being instrumental in these meetings with APS.

As per our latest review with APS, our authorizer, the following policies needed to be created or revised:

Employee Complaint and Grievance Policy
Background Check Policy
Teaching Controversial Issues Policy
Conflict of Interest and Nepotism Policy
Medication in School Policy

After a brief discussion of the policies occurred and were accepted.

Chairman Hatchell provided information concerning Mrs. Stephens-Shauger's mid year evaluation. After a brief discussion it was noted items of review will occur in January and in February the mid-year evaluation will be completed and shared with Mrs. Stephens-Shauger.

On January 3, 2019 Governor Lujan-Grisham completed an executive order stating there will be a New Mexico will transition away from PARCC and adopting new ratings and assessments that evaluate where the students are struggling. In transition there will be the same technical assessment with comparable to PARCC with a ranking 1 to 5. The assessment will be shorter, 6 hours versus 8 hours. The transition appears to be streamlined, and working with the new PED administration has appeared to be much easier. Mrs. Stephens-Shauger will keep the Governing Council updated.
