2. Audit Committee

IX. Co-Directors' Report

Short-cycle testing Data (Casey Mason)
 Casey Mason presented a report on short-cycle English and Math testing results.
 This data is different than PARCC or SAT and is designed to measure student growth.

The reading data reveals challenges in this area, but ACE has been actively emplacing resources to try to address this moving forward, including hiring a Reading Interventionist and implementing study aids. Math has seen some movement in the right direction.

Need to determine what are the right measures for ACE when we look at education data. This is a topic for the Board Retreat.

Justin Trager

- 7 positions have been added this year. Some of these are soft money.
- Significant grants have been awarded, including \$100,000 for Educational Assistants as well as a community planning grant and \$257,000 for a PED Innovation Zone Grant. This is a 1-year grant. This will fund student internships, as well as a data system, travel and PD.
- He stated that students will return to ACE on August 8th.
